

3/16/20 Updates:

We are taking proactive measures to ensure the health, safety and financial stability of our team members and company. We are taking actions to support the countries efforts in reducing the spread of the COVID-19, as well as ensuring the continued supply to our customers. Jireh continues to monitor the situation with the Pandemic COVID-19 virus each day, and will continue to communicate and react according to the guidelines for the Center for Disease Control (CDC).

PREVENTION

The best prevention for viruses, such as influenza, the common cold or COVID-19 is to:

- <u>Wash your hands often</u> with soap and warm water for 20 seconds.
- Avoid touching your eyes, nose or mouth with unwashed hands.
- Cover your mouth and nose with a tissue or upper sleeve when coughing or sneezing.
- Avoid contact with people who are sick.
- Practice "social distancing". Keep at least **6 feet distance** from each other when possible.
- If you are sick, stay home and avoid contact with others.
- Extra cleaning measures: Please help us clean and disinfect your work areas as well as common areas when possible.

Team members may be notified of exposure experienced during recently attended events and be asked to self-quarantine as a result. If your children's school or daycares closes, if you have either tested positive to COVID-19, if you have been in direct contact with someone who has tested positive to



COVID-19, or if you received formal notification to quarantine, we will modify our attendance and paid time off policies (with proper documentation) to allow you time to make the necessary arrangements.

Undoubtedly, we will have team members and their families impacted. We thank you in advance for being as flexible as you can in making sure we take care of our customers. <u>Your safety is most important</u>.
